2016 Champions for Charity Opportunity Drawing – RULES

Description of Opportunity Drawing:

On October 15, 2016 at the Long Beach Symphony POPS! concert of the 2016–2017 concert season, the Long Beach Symphony Association, LBSA, (dba Long Beach Symphony Orchestra, hereafter “LBSO”) will conduct an Opportunity Drawing. Tickets must be purchased on or before Saturday, October 15, 2016.

Tickets will be available for sale from August 22 – October 15, 2016 for **\$100** per ticket.

Chances of Winning:

No more than 200 tickets will be sold. The chance of any individual ticket being the winning ticket will be at least one in two hundred. Odds of winning may increase based on the purchase of multiple tickets, or if fewer than the maximum number of tickets are sold by the deadline.

The prize shall be awarded on Saturday, October 15, 2016. The holder of the winning ticket does not need to be present to win.
